J. A. [Tony] Allan (United Kingdom) is a Professor of geography at King's College, University of London. He gained a first degree at Durham University in 1958 and his Ph.D. at the School of Oriental and African Studies (SOAS) in London in 1971. His research focuses on the social and political contexts which influence and usually determine water use and policy, and has deployed a wide range of environmental, economic, social, and political theory that takes into account the underlying fundamentals of water in the hydrological cycle and the impact of engineering interventions. The difficulties of scientists and professionals in gaining a place for their 'knowledge' in water policy discourses is his major current research theme. In the Middle East and North Africa, the water crisis has been ameliorated through the availability of 'virtual water' embedded in food traded internationally. A second research focus is global water resource and the extent to which global resources will be sufficient to meet the needs of future populations. The rich diversity of the theorisation is a feature of the international contribution of the Water Issues Research Group he founded at SOAS.
