Progress made in the formulation and implementation of subregional and regional action programmes in Africa (ICCD/CRIC(3)/2/Add.2)

*Outcome of subregional workshops of affected African country Parties (ICCD/CRIC(3)/2/Add.4)* 

The Chairperson made a statement.
